




5. The college has given me full freedom to adopt new techniques / strategies of teaching such as group discussions, seminar presentations and learners' participation.




6.I have the freedom to adopt new techniques / strategies of testing and assessment of students.






7. Tests and examinations are conducted well in time with proper coverage of all units in the syllabus




8. The prescribed books are available in the Library in Sufficient numbers.






9. The environment in the College is conducive to teaching and research




10. The administration is teacher friendly.






11. The college provides adequate opportunities and support to faculty members for upgrading their skills and qualifications.




12. ICT facilities in the college are adequate and satisfactory.






13. Separate space in college Canteen is available for Teachers




