### Introduction

• Energy Efficiency: Promote the use of energy-efficient appliances and lighting. Encourage initiatives such as the use of solar panels.

### Solid Waste Management

**Reduce, Recycle and Reuse**: The garden waste, garbage, paper, e-waste and laboratory waste are **segregated** as per the Nalwadi Grampanchayat Guidelines.
