Kindly clarify. (Please note that in all documents the name of the institution should be the same)

### Clarification:

Earlier NEW ARTS COMMERCE AND SCIENCE COLLEGE was the name of the college which was run/managed by society MAHILA VIKAS SANSTHA, Wardha . Later on the name of the college was change as INDRAPRASTHA NEW ARTS COMMERCE AND SCIENCE COLLEGE. It is also run/managed by same society MAHILA VIKAS SANSTHA.

We Find that, there is nothing wrong to mention the name of parent society which run/managed Institute. We have change name of the college with prior permission of Rashtrasant Tukadoji Maharaj Nagpur university, Nagpur. It is observed in Self Declaration Certificate coursed offered under B.A - Geography, Home Science, Hindi, Arts, Sociology, Ancient History, Sanskrit and B.Sc. -Physics, Chemistry, Mathematics, Zoology, Botany are mentioned, but these subject is not reflected in the IIQA Application, University Affiliation Letter and Institutional Website . Kindly clarify.**

**Clarification:**

It is sorry to say as we have not mention in self declaration the subject like BA-Home Science, Ancient History and Sanskrit and therefore these subject not reflected in IIQA, neither in University affiliation letter or in Institutional website. Probably this mistake may be at your level. So far the subject B.Sc is concern we

have permission from Government of Maharashtra and RTM, Nagpur University, Nagpur to teach the subject **Physics, Chemistry, Mathematics, Zoology and Botany**. Out of these five subject students have not opted Zoology and Botany and therefore these subjects are not reflected in IIQA.

Zoology and Botany these subjects are mention in university affiliation letter dated 17/06/2022. Since students are not opting Zoology and Botany these subjects are not mention in Institutional Website. In self-declaration we had given the details of Program/Subject not taught by institution mention as per given format.


5. **It is observed in University Affiliation Letter Programme details Under UG-BA-Supplementary English, Psychology, & BSc-Bio Chemistry, Electronics, Plant Science and PG-MA- Gross Economics, English are mentioned but same is not reflected in IIQA Application Si. No. 22. Kindly clarify.**

**Clarification:** It is fact that we have permission from university to teach the subjects like UG-BA-Supplementary English and Psychology & BSc-Bio Chemistry, Electronics and Plant Science. But BA-Psychology, B.Sc -Biochemistry, Electronics, Plant Science(Botany) are not opted by the students and therefore these subjects are not reflected in IIQ. So For PG-MA we don't have a subject Gross Economics as name by you. We have permission to teach subject English as PG Level, But the students are not opting the subject thus it not reflected in IIQA. In self-declaration we had given the details of Program/Subject not taught by institution mention as per given format.



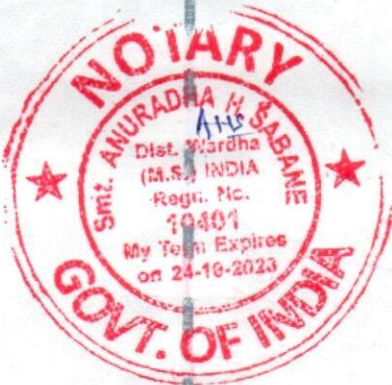

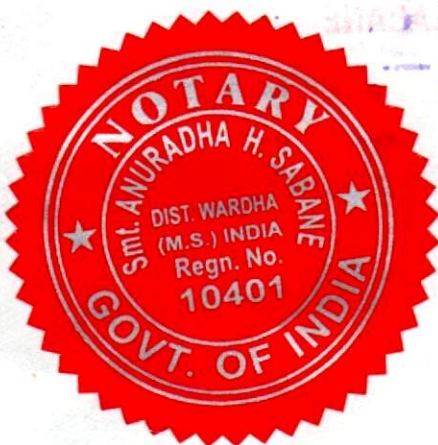
